LEGISLATIVE ALERT

On May 1, 1997, Assembly Bill No. 2777 was introduced by Assemblyman Amone. The bill, described as "The Third Omnibus Mandate Relief Act", was entitled An Act Revising Certain Mandates, Requirements and Procedures for Local Governments and School Districts and Amending Supplementing and Repealing Various Parts of the Statutory Law. A-2777 relates to some 89 issues. Looking at the title and

reading the reports in the newspaper, we would never suspect that the bill pertains to Assessors. The press reports I have seen all focused on the school district portion of the bill.

The League of Municipalities sent a Legislative Alert to its Mayors on May 14 requesting that it be distributed to, among others, all department heads. This notice included "Mandates Relief – Round III" along with several other issues. Judging from the response we received, very few Assessors were copied on this material. During the business meeting on Tuesday, June 3, at the Rutgers Conference, I was asked what I knew about A-2777. My answer was nothing, because, having read the title. I thought it did not affect Assessors.

As quickly as possible after the conference. I had my first copy of the bill and learned that it definitely did have a major impact on Assessors! The sections below relate to our position. (The section numbers are from the Committee Substitute A-2777).

Section 35 - Amends 4OA:9-166 to add the following sentence:

"The appointing authority may, by resolution or order as appropriate, set appropriate hours of operation of the tax assessor's office and the work hours of the tax assessor, commensurate with the compensation of the tax assessor."

Section 36 – Amends 40A: 9-148 and adds the following to the description of an assessor's term:

"...however, the first 12 months of any initial term shall be a probationary period during which time the municipal tax assessor or deputy assessor, as appropriate, may be removed from office for unsatisfactory performance or FOR ANY OTHER REASON by the appointing authority. (Emphasis added.) Removal during a probationary period shall be considered a vacancy due to expiration of term."

Section 37 – Amends 40A:9-165, which now reads in part:

"No such ordinance shall reduce the salary of, or deny without good cause an increase in salary given to all other municipal employees to, any tax assessor, chief financial officer, tax collector or municipal clerk during the term for which he shall have been appointed."

The proposed change would result in the following language:

"No such ordinance shall reduce the salary of, with out good cause, any tax assessor, chief financial officer, tax collector or municipal clerk..."

THESE ARE MAJOR CHANGES!!!

The only other sections relating directly to us are sections 53 and 54 which change the mailing of the assessment notice from annual to annual or biennial at the direction of the governing body. I am aware that there are

THE EDITOR SPEAKS





differences of opinion within our group, so I will only remind everyone that the purpose of the notice is to inform taxpayers of their assessments so that they might be able to determine the need for an appeal.

On June 9, the Monday after the Rutgers Conference, A-2777 was heard and amended by the Assembly Local Government Committee. At that time Assemblywoman Murphy and Assemblymen Augustine and Weingarten were added as sponsors. Upon release from the committee, the bill, now know as Assembly Committee Substitute for A-2777, was referred to the Assembly Appropriations Committee. On Thursday, June 12, Senate No. 2205, sponsored by Senator Scott, was introduced in the Senate and referred to the Senate Budget and Appropriations Committee.

On Wednesday, June 18, we became aware that a hearing was scheduled in the Assembly Committee for Monday, June 23, at 9:30 a.m. A telephone call program was implemented to recruit assistance from Assessors around the state in contacting committee members to explain our position. On Friday, June 20, we were advised that the Senate version would be heard in committee 10:00 a.m., June 23. Late that afternoon it was decided that AMANJ President Hobbs, Attorney John Lloyd and I would be in Trenton for both hearings.

Fortunately our efforts and the efforts of other affected groups were able to result in both bills being held in committee "at the request of the sponsor." Beyond that A-2777 was scheduled for a floor vote on Thursday, June 26. This also did not occur.

The pressure is temporarily off. These bills could and probably will move again when the legislature returns in the fall. All of us need to express our concerns to those members of the legislature with whom we have good relationships. The independence of future Assessors is at stake!

LEGISLATIVE COMMITTEE **REPORT**

Senator Robert J. Martin's bill to revise access to public records (S-332) was on the agenda for a meeting of the State Budget and Appropriations Committee on Monday, June 23, 1997. We were concerned about the bill because of the nature of some of the information we collect in the course of the assessment process. While we were prepared to testify in opposition to the bill, a pre-meeting conference with the sponsor made us aware that our concerns were addressed by one of the proposed amendments scheduled to be adopted at that meeting. The amendment in question is contained in section 14 of the bill as amended. This section begins with the general statement: "Nothing contained in this act shall be construed to require or permit disclosure of . . . " A long list of specific items follows, outlined alphabetically. Item "v" in this list reads:

"... property record cards maintained by municipalities or tax assessors; provided, however, that a requestor who has filed a tax appeal shall not be prohibited from obtaining through the ordinary course of discovery in the tax appeal the property record card of the property under appeal as well as the property cards of any properties being used as comparables."

We believe that this amendment should alleviate any concerns regarding property record information and when signed into law, should be helpful to us.
