## RECENT TAX COURT DECISIONS

Atlantic City v Greate Bay Hotel and Casino

After taxpayer filed property tax assessment appeal with county board of taxation, city brought action challenging assessment of taxpayer's property. Taxpayer moved to transfer city's complaints to county board of taxation. City moved for order determining jurisdiction. The Tax Court, Rimm, JTC, held that it had jurisdiction over real property assessment appeal pursuant to statute.

## Friends of AHI Exer Congregation v Long Branch

16 NJ Tax 591

Religious organization appealed judgement of county board of taxation affirming tax assessment of real property which was residence of organization's rabbi. The Tax Court, Axelrad, JTC, held that: (1) rabbi was not officiating clergyman within meaning of parsonage exemption statute, and (2) nonexempt nursing home at which rabbi performed services was not church or synagogue for purposes of parsonage exemption.

#### Jersey City v Parsippany-Troy Hills 16 NJ Tax 504

City appealed township's property tax assessments on its water supply property. The Tax Court, Kuskin, JTC, held that: (1) highest and best use as reservoir could not be considered when valuing publicly-owned water supply lands; (2) property having highest and best use as reservoir could not be valued using comparable sales of developable uplands; (3) water did not constitute improvement for purposes of valuation statute; (4) wetlands, transition areas, buffer area and underwater land could be valued based on highest and best use for conservation and open space; and (5) value of publicly-owned water supply land need not be discounted based on Watershed Protection Act.




