

#### THE EDITOR SPEAKS

It's a new year and the Governor wants our scalps. Or more particularly she wants Assessors to become *County Employees*. This is the upshot of her big Property Tax

Commission. Can you imagine how much money this will save? I'm sure that every single municipality in New Jersey will be able to balance its budget once the Assessor is a County Employee. I can see it now. In municipal buildings all over the state, CFO's will be dancing because they won't have to fund the Assessor's Office. Whee!



Mayors and Council members will be looking for places to spend the new found surplus. "Go get 'em Queen Christie! Get the Tax Assessor off local government's back."

If you just woke up, in her annual Budget Address, Governor Whitman recommended that the local assessment function be consolidated at the County level and funded by the State. This would magically eliminate any and all inequities in the assessment function and save taxpayers money. Of course she also gave herself an "out" by mentioning the vested interests (AMANJ maybe) who are against this "progressive" measure.

All sarcasm aside what's note-worthy about this proposal was that the Governor made it in an important address. It wasn't buried in the body of some obscure report from some more obscure state commission. It came straight from the Governor's lips. If she can sell this to the Legislature as a cost saving measure with grass roots support, there is a possibility that sometime soon Municipal Assessors will go the way of the dodo. It could even happen this year.

How did it get to this? That's a good question. AMANJ has a lobbyist who is doing a good job getting our views across to

the legislature. Many AMANJ members know some political big shots. If we as members of AMANJ don't care if this happens, it probably will happen. The next few months will see some major jockeying for position. This could be an interesting time.

So what do you do? What's the AMANJ Board of Directors do? What's the next step? We have to wait and see how Governor Whitman is going to approach this. Our lobbyist is keeping the lines of communication to the Legislature open. Some Assessors will probably be asked for testimony at committee level. You could mention to your Mayor or Township Administrator that this is in the works. Let him know that if it happens, you won't be around to give him answers or do the myriad other coordinated efforts concerning property and value and taxes that he needs but that are not in your job title.

If the League of Municipalities (basically the Mayors and governing bodies) are against this proposal, there isn't much chance of it happening. But we have to let them know. We've got to toot our own horn a little bit around Town Hall. Otherwise we'll be tooting our horns in the county garage.

In the Governor's defense it should also be noted that consolidation of government services is a common theme and consolidating Assessors was only a small part of her overall message. She also mentioned consolidating fire departments and school districts.

Assembly Speaker Jack Collins (R-Salem) was quite skeptical of her efforts toward consolidation. He spoke of many polls showing that taxpayers were not willing to give up control of their school districts, etc. If Governor Whitman wants to implement her proposals, she'll need the Speaker's support.

One of the things the Governor mentioned was the "fragmented and inconsistent" system of local property taxation. Consistency in assessments is a magical ideal, one every Assessor is committed to. But removing the local Assessor from the equation will not necessarily make for more consistency. It may make the problems bigger not better.

#### **Recent Tax Court Decisions**

## Atlantic City v Ginnetti

City appealed County Board decision seeking an increase. Taxpayer filed a counterclaim seeking a further reduction. The Tax Court (Rimm, JTC) ruled that the property was a single economic unit and an increase was warranted.

This case shows the difficulty of assessing and appraising Atlantic City property. Three tax list parcels were appealed. There was a fourth parcel that was not appealed but was held to be part of the "economic unit" with the other three. The fourth parcel contained a total of six square feet and was one inch by 100 feet deep.

Judge Rimm ruled that the property was best held for casino development. He disregarded taxpayer's expert's sales of foreclosed properties and properties some distance from the subject.

This is an interesting case showing how volatile the Atlantic City market is.

#### Levitz Furniture Corp v Paramus

17 NJ Tax 483

Taxpayer appealed local tax assessment of furniture store. The Tax Court (Kahn, JTC) ruled that (1) the income approach was proper; (2) municipality's valuation was more reliable than taxpayer's because it was based on property's highest and best use; (3) contract rent for comparable properties was most reliable evidence of market rent; (4) rents for comparables had to be adjusted for subject property's greater warehouse area; and (5) a landlord's expense to improve subject property for tenant was too speculative to be included in operating expenses. The Assessment was affirmed.




